Course Description

This course is a survey of Tohono O'odham historical, culture, and contemporary issues after 1980. Includes how European contact forever changed the land, lives, and culture of the Tohono O'odham. Sources of Tohono O'odham history will be analyzed in terms of social, political, and economic development of Northwestern Mexico and Southwestern United States.

Student Learning Outcomes

Upon completion of the course, the student will be able to do the following:

- 1. Describe the social, political and economic factors affecting Tohono O'odham society since the 1980s.
- 2. Identify and explain the chronological events that shaped the history of Tohono O'odham society.
- 3. Analyze the impact that different colonizing groups and events have had on Tohono O'odham society since the 1980s.

Course Structure

This course is Asynchronous which means that there are no scheduled class meeting times. However, you will have many opportunities to interact and be part of a learning community in this course via Canvas. The advantage of Asynchronous Learning is that you have flexibility when you work on the course, however, this type of course requires good time management skills and the ability to learn independently. Also, even though your time is flexible, there are course deadlines you will need to keep track of/meet.

Himdag Cultural Component

HIS125-1 will allow students to participate in culturally-relevant activities that reflect Himdag; T-O'odhamtalig;(deep respect for our language, our land, our songs, our dances, our prayers, our orations); and T-Pi:k Elida;(deep respect for the earth, plants, animals, and the people); Na:nko Hai'cu T-Na:toidag(arts); Hai'cu Wohocudadag (beliefs); Na'nko Hai'cu T-Himdag(ceremonies); T-Ki:dag(community); Jewed c Jewed We'gac Ha'icu(land and environment); and T-Neneni kc T-Piast(songs and music).

Policies and Expectations

Attendance Policy (Re: asynchronous online classes)

You are expected to actively participate in this online course. Attendance is taken by the completion of reading assignment and writing reflections which are due weekly. Four consecutive missed due dates may result in a letter grade of "F" or an instructor withdrawal "FW" (see 45th-Day Instructor Withdrawal policy). You may request to be excused from class for religious observances and practices, for illness, for school or work-related travel or for personal or family emergency. If you will be absent, please notify the instructor as soon as possible.

Incomplete Policy

Incomplete (I) grades are not awarded automatically. The student must request an "I" from the instructor who can choose to award an Incomplete only if all three of the following conditions are met:

- 1. The student must be in in compliance with the attendance policy.
- 2. The student must have unavoidable circumstance that would prohibit the student from completing the course.
- 3. The student must have completed over 75% of the course requirements with at least a "C" grade.

Incompletes are not a substitute for incomplete work due to frequent absences or poor academic performance. Incomplete grades that are not made up by the end of the ninth week of the following semester will be automatically changed to an F if the agreed upon work, as stipulated on the written form signed by the instructor and the student when the I grade is awarded, is not completed.

45th-Day Instructor Withdrawal Policy "FW" (Re: asynchronous online classes)

Students who have missed four (4) consecutive course due dates for learning activities, participation, assignments, quizzes, exams, by the 45th - day census report, due on [date of 45th - day found in Academic Calendar on TOCC website] are assumed NOT to be participating in the class and may be withdrawn at the faculty member's discretion.
