Each speech will be worth 100 points. All speeches (except the 5 minute Introductory Speech) will be approximately 10 minutes in length. The grade will be determined by the instructor. Each of the 6 discussion posts will be worth 50 points and should be a minimum of 400 words.

Students will use whatever platform they prefer to record videos and send the professor a link or means of accessing the file.

The instructor will record weekly lectures which will be posted on Canvas.

Discussion Posts/Reviews: 350 points (50 points each) 37%
Six Speeches 600 points (100 points each) 63%

Policies and Expectations

Attendance Policy

As this is an online course attendance will not be taken as such. Participation in the discussions and the timely submissions of assigned work will be used instead.

Incomplete Policy

Incomplete (I) grades are not awarded automatically. The student must request an "I" from the instructor who can choose to award an Incomplete only if all three of the following conditions are met:

- 1. The student must be in in compliance with the attendance policy.
- 2. The student must have unavoidable circumstance that would prohibit the student from completing the course.
- 3. The student must have completed over 75% of the course requirements with at least a "C" grade.

Incompletes are not a substitute for incomplete work due to frequent absences or poor academic performance. Incomplete grades that are not made up by the end of the ninth week of the following semester will be automatically changed to an F if the agreed upon work, as stipulated on the written form signed by the instructor and the student when the I grade is awarded, is not completed.

Instructor Withdrawals

Students who have missed four consecutive classes (or the equivalent) not submitted any assignments nor taken any quizzes by the 45th day census report, due on [date of 45th day found in Academic Calendar on TOCC website] are assumed NOT to be participating in the class and may be withdrawn at the faculty member's discretion. Student Withdrawals
